## DIRECTIONS

ENGINE CLEANING - Use 1 part BLUE MONSTER to 1 part water. Spray-on, wipe off or rinse with a high pressure spray.

TIRE CLEANING - Use 1 part BLUE MONSTER to 2 to 3 parts water. Normally no rubbing is required but, scuff marks and stains may be removed by applying with a brush. Rinse off.

PRESSURE WASHING - Use 1 part BLUE MONSTER to 40 - 50 parts water. Rinse off.

USE RUBBER GLOVES, CHEMICAL SPLASH GOGGLES, IMPERVIOUS CLOTHING AND RUBBER BOOTS WHEN APPLYING PRODUCT. DO NOT USE ON PAINTED SURFACES OR ALUMINUM AND MAG WHEELS.
