DIRECTIONS:

For use in removing road film, tar, and glue adhesive off of painted surfaces. Apply on a clean terry cloth or microfiber towel. Rub gently until contaminants are removed. Do not apply a lot of pressure while removing contaminants, especially on dark-colored vehicles. Do not apply in direct sunlight. Always rinse with soap (Gala Gold) and water when finished.

PRECAUTIONARY STATEMENTS - Prevention:
